3) Hazards Identification

Physical Highly Flammable. R-11

Adverse Human Effects Can enter the body by inhalation, ingestion, or through the skin.

Irritates the eyes, skin and respiratory tract.

Liquid removes the skin's natural oils.

Repeated exposure may cause skin dryness or cracking. Vapours may

cause drowsiness and dizziness.

3) First Aid Measures

Do not contaminate water sources or sewer.

Shovel up and remove to a safe place.



Extinguish naked flames.

Ensure adequate ventilation.

Wear protective clothing and breathing apparatus as outlined below.

7) Handling and Storage

Handling Precautions Ensure adequate positive ventilation to keep concentrations well below

hazard levels.

Keep away from heat, sparks and open flames.

Storage Precautions Containers must not be exposed to direct sunlight or temperatures above

50°C.

Store away from oxidising agents.

Avoid exposure to sources of heat or ignition.

Keep containers tightly closed.

Avoid build up of static electricity.
